### **Artificial Intelligence Use Policy**

The University's Academic Honesty and Integrity Policy defines important obligations students have regarding their academic and non-academic pursuits. The Artificial Intelligence (AI) Use Policy is a subset of the University's Academic Honesty and Integrity Policy, intended to clarify the responsibilities of students using AI.

Generative artificial intelligence (AI) tools such as ChatGPT, Gemini, and Copilot, and generative AI Writing Assistance tools, such as Grammarly, are shaping our work the work we do in teaching and learning. When used within the scope of the policy and within the guidelines designated by the instructor, generative AI can be a helpful tool to support learning and provide opportunities to explore and understand information. When used improperly, there is risk of biased interpretation, incomplete or inaccurate information, lack of proper attribution and/or plagiarism. Students should exercise caution in the use of such tools and follow the explicit guidelines provided by each instructor that describe the level and type of AI use permitted in each course.

Students are ultimately responsible for the coursework they submit and should not attempt to submit any AI-generated work as their own. Per the University's Academic Honesty and Integrity Policy, all submitted work should include correct and complete citations. Specifically, students are not to use

unauthorized assistance in coursework, internships, fieldwork, or scholarly activities unless such assistance has been authorized specifically by the course instructor.

Instructors assign one of three AI levels (full use, guided use, or restricted use) to each course, as designated in their course syllabus. In general, predictive text tools built into commonly used applications are permittable in all three levels.

**Full Use.** Students may use any AI writing tool to help with brainstorming and improve their writing style, clarity, and expression (grammar, punctuation, spelling, sentence starters, transitions between

paragraphs), as well as predictive AI tools built into common applications. It is the student's responsibility to verify the credibility, accuracy, and trustworthiness of all information used from AI tools. Any text copied directly from an AI tool into their own writing assignments without appropriate citation is considered plagiarism. If an instructor finds or suspects a student has plagiarized, the student will be expected to meet with the instructor to discuss the impact of the student's actions on their grade. Any violation of the Academic Honesty and Integrity Policy is subject to additional action, as outlined in the University's policy.

**Guided Use.** Students may use AI generative technologies as directed by the instructor. They may fully use predictive AI tools built into common applications. In this course, students will use generative AI in a guided manner to ensure students are meeting the student learning outcomes that structure this course and others in our program. AI use guidelines will be defined and provided with each relevant learning activity.

**Restricted Use.** Students should refrain from using generative AI tools in this course. They may use predictive AI tools built into common applications. In this course, students will not use generative AI to ensure students are meeting the student learning outcomes that structure this course and others in our program. Any use of generative AI in this course is a breach of the University's Academic Honesty and Integrity Policy and subject to disciplinary action, as outlined in the University's policy.
